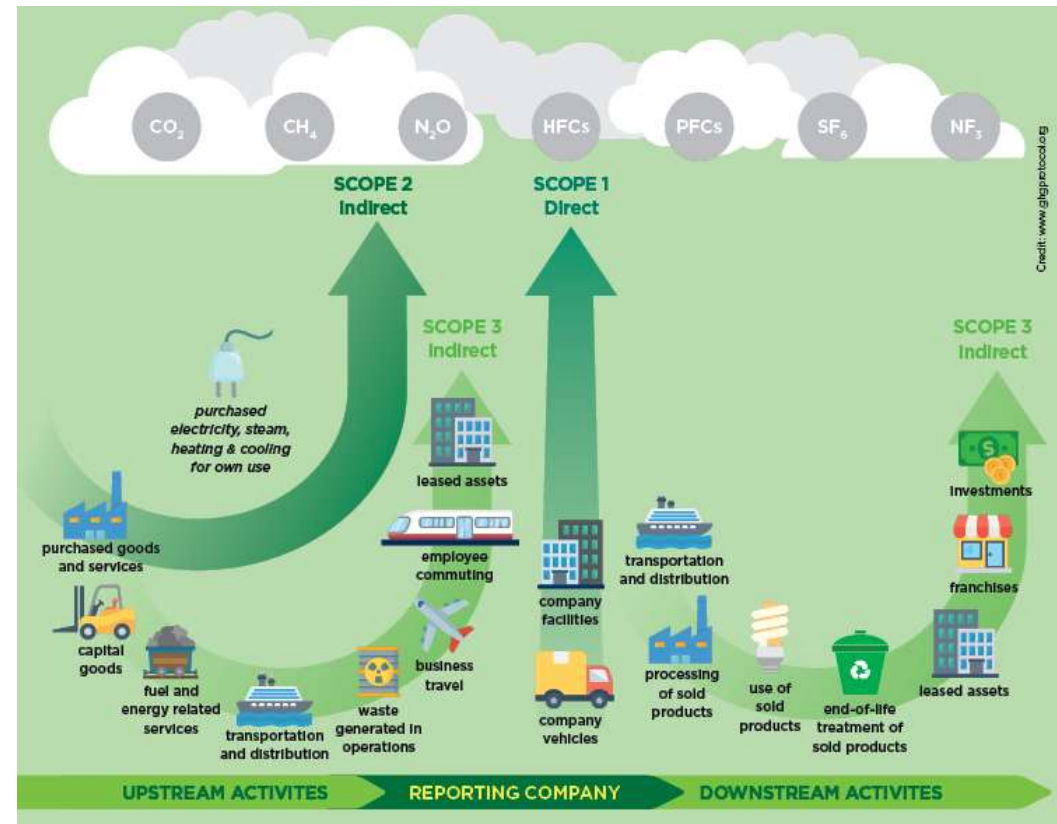

PPG 2025 sustainability goals and 2021 progress



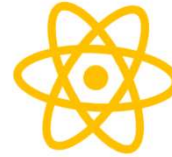
